Terms of payment

- Advanced payment
- All prices plus VAT
- Export in EU-Countries is without VAT, in case of a valid VAT-reg. number

Terms of delivery

- EXW Sulzbach-Rosenberg
- The products can be delivered only after the payment is on the account of ATH-Heinl
- In case of a delivery within the EU the CMR has to be signed with stamp, arrival date and signature and has to be send back to ATH-Heinl (email or fax) as proof of delivery (PoD)

Guarantee and Service

- Distributor of ATH products have one year of warranty for the spare parts, the broken parts has to be sent back to ATH-Heinl
- The working hours at the customer for guarantee reasons has to be made by the distributor and won't be refunded
- ATH-Heinl offers the distributor for one year an "In-House-Guarantee", which means that the distributor can send the products to ATH-Heinl for a free repairing. The transport costs has to be paid by the distributor
- Technical consulting and trouble shooting for the customers has to be done from the distributor
- Sales persons and technicians can take part in trainings for the products at ATH-Heinl
- The distributor receives sales information (pictures, advertising material and user manuals) from ATH-Heinl, for a needed translation into the national language the seller is responsible
